## Continuous screening test simulator

In the "Current" environment a simulator is available as a test tool. The simulated continuous screening has the following behavior.

- The merchant registers monitors with collections of example individuals in a usual matter
  Once every night, between 1 and 3 people in a simulated monitor will be selected as new Pep or Sanction individuals. Alerts are generated, and webhooks will be triggered.
- These nightly simulated alerts will repeat until there are no more people left in the monitor
  To resume testing, the merchant simply has to add more people to the monitor.
- Data returned in the alerts are hard coded and static.

**(**) During development and integration testing it might be convenient to trigger immediate alerts and webhook callbacks without having to wait for the regular nightly events.

A particular test person, Tomas Topstad (01010750160), has been prepared for this purpose and will trigger such immediate alerts and callbacks.
